4. yDNA study at FT DNA on the Kip-Kipp Families

The actual group has a number of results for various Kip and Kipp families. Edward's line emigrated to the United States from The Netherlands to New Amsterdam/New Nork. As well there were emigrants directly from Germany in the 1750s to the United States but I will not discuss those results. I welcome anyone else to submit articles to this Newsletter.

Having done one Y-700 test for Edward the information it reveals is quite interesting.

There appear to be five distinct groups within the yDNA study. The tester from the Netherlands wrote to Edward to say he was curious if his line would match the lines in the United States and he does not. But his ancestry is known to be German and the Kipp surname from Germany has three different lines leading one to suspect that the surname itself was chosen by several different families in various parts of the Germanic states. Edward's line arrived in the 1630s from The Netherlands in New Amsterdam now New York nearly four hundred years ago and it is unknown whether Hendrick Hendrickson known to be progenitor of this line has any descendants in Europe.



Since the last newsletter, FT DNA has provided results for one of my husband's Kipp cousins (they are both descendant of Issac Kipp who lived at Northeast Town, Dutchess County, New York coming to Canada as a settler in October 1800. Edward's Y-700 test revealed a lot of information about this specific Kip/Kipp line descendant of Hendrick Hendricksen Kip of New Amsterdam (now New York). FT DNA has used the results uploaded of the autosomal sample and noted the yDNA. It is interesting and does lead to R-Z326 which would be expected.


It is interesting having this extra bit of information from a test that was primarily to look at autosomal DNA.

Having tested Edward at all of the major testing companies I have had quite a bit of information to draw on from the National Genographic Study, FT DNA itself with the Y-700 test as well as 23 and Me which also looks at the vDNA of the sample. 23 and Me has provided an update on his sample which shows 88.3% French and German (interestingly the first match is in the area often of the birthplace of Hendrick Hendricksen from his marriage lines), Scandinavian 7.6% (he does have 3x great grandparents with Scandinavian ancestry), British and Irish 1.9% (his Dissenters from the British Isles were basically 7x great grandparents), Broadly Northwestern Europe 1.4% and Eastern Europe 0.6. He is also listed as being part of the European Diaspora and that certainly fits in with his New Netherlands early arrivals as well as the Dissenters from England who came to America. This is a new update 22nd October 2024. At 23 and Me his paternal haplogroup is identified as R-Z326. Edward also tested at Living DNA and Ancestry. One notes that Living DNA identified his y-DNA also Z-326. Edward's mother had mostly German ancestry on her father's side and French/Dutch ancestry on her mother's side. I do think he inherited heavily from Germanic ancestries in his lines given the matches which he has and this latest result from 23 and Me.

Edward's results of the Y-700

Looking back along the Haplogroup line (two steps back from shaded line) there are 15 individuals who have the R-Y20961 mutation including Edward Kipp. The Country of origin for these individuals is 6 in the United States (my husband was Canadian but his ancestor for this study was American coming to Canada as a settler in 1800), 5 in England, 1 in the United Kingdom, 1 in Wales and 2 unknown. This mutation is thought to have commenced around 500 CE (Common Era). That does rather indicate a long period of time with just the single mutation between which gave rise to R-FT245480 the furtherest down mutation in the Y-700 test for Edward Kipp and the two individuals who match him in the FT DNA database (Norwegian). Last newsletter I mentioned that movement to Norway occurred earlier for his matches and this appears to be a return to the European continent in the case of my husband's result. The other possibility is that his line never left the Continent and resided within 100 km of Amsterdam since that is the general location of this particular set of results which define his haplogroup.

I have not yet investigated the Norwegian results especially but will continue observing them given that Edward's ancestor was known to have arrived in New Amsterdam in the latter part of the 1630s and also known to have migrated from Amsterdam, The Netherlands.
